EMANELMENT OF CHEMISTS FOR CGHS AGARTALA FOR THE PERIOD - 2017-2020

Applications are invited from reputed Local Chemists of Agartala City for empanelment to supply medicines to the Central Government Health Scheme Wellness Centre Agartala, Ministry of Health & Family Welfare, Government of India. Bidders are advised to refer to the tender published against the Wellness Centre that is provided at Annexure-'B'. Bidders are advised to participate online at '<https://eprocure.gov.in/eprocure/app>' corresponding to the tender of the Wellness Centre. The bidder will have to upload required documents & Bids for the Wellness Centre online.

The tender notice can be downloaded from the Website www.eprocure.gov.in/eprocure/app or <http://msotransparent.nic.in/cghsnew/index.asp> of the Ministry of Health and Family Welfare.

Eligibility Criteria:-

1. The chemist must hold valid licenses as on the date of submission of Bid in specified Forms 20, 21 and 21-C (for continuance of retail licenses, if required) issued by the Drug Control Authority of the State under the provisions of Drugs and Cosmetics Act, 1940. The successful Bidder will further ensure that their licenses remain valid on the date of bid opening and till the end of the contract period.
2. The chemist must not have been convicted by the State drugs authorities and no case should be pending under the Drugs and Cosmetics Act and Rules.
3. The annual turnover of the bidder is based on the city as per its classification for the purpose of grant of HRA by the Ministry of Finance, Department of Expenditure OM No. 2/5/2014-E.II(B) dated 21/07/2015. Annual Turnover in the last financial year should not be less than Rs. Sixty lakhs in Cities classified as Class 'X' cities, not less than Rs. Forty Lakhs in cities classified as Class 'Y' cities and not less than Rs Twenty Lakhs in remaining cities (Agartala)('Z' cities). The bidder has to submit an Audited Balance Sheet with Profit and Loss statement of the last financial year in support thereof.
4. The chemist shop / commercial establishment should be situated within the CGHS covered area of the city or the Municipal limits of the city, whichever is applicable.
5. Latest VAT deposit challan should be available with the bidder.
6. A copy of PAN allotted to the bidder.

Enquiries will be entertained in the pre-bid conference only. The Additional Director CGHS, Shillong reserves the right to reject all / any application received from the Chemists without assigning any reason.


